Wholesale Terms & Conditions

BENEFITS

Wholesalers are able to take advantage of the a 50% discount on printed paper patterns with a minimum order requirement of 10 per pattern, at least one pattern per order.

PURCHASING

All purchases are completed online through www.sewgnar.co. Once all paperwork has been received and approved, your profile will show a "wholesaler" designation and will allow you into the Wholesale side of the online shop. There you can place wholesale orders, see order history, and update any pertinent information.

SHIPPING

Shipping and Handling is not included in the price shown for each pattern. Your order will ship via USPS within 5 business days (unless a different time frame is agreed upon prior to order). The shipping amount will include insurance in the event of an issue. Shipping will populate automatically based on weight. Overages of \$2+ will be refunded.

PAYMENTS

All payments are completed through Paypal via the SewGnar website. You do not need a PayPal account to complete payment. All major credit cards accepted (MasterCard, Visa, Discover, and American Express). All payments must be completed prior to shipment.

RETURNS

Returns are not accepted unless product is defective or has missing parts. Authorized returns will be be refunded in full minus a 5% restocking fee. Do not send back an order without prior approval. In doing so, you may forfeit any monetary return for items.

INTERNATIONAL WHOLESALE

International customers must adhere to these guidelines. All payments must be equivalent to your country's currency and must be paid in full prior to shipping. You will receive tracking information at the time of shipment.

INTERNATIONAL DUTIES & TAXES

SewGnar will not be responsible for the payment of any customs levies, duties or, taxes that may be associated with the delivery of wholesale orders in your country. **Wholesale customers are solely responsible for any such fees.**

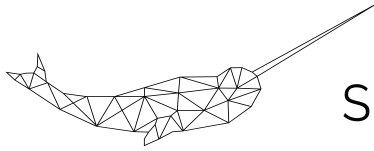
CHANGES TO WHOLESALE

- Above Purchaser further certifies that if any property so purchased tax free is used or consumed by the firm, company, organization, affiliate or as an individual as to make it subject to a Sales or Use Tax, Purchaser will pay the tax due directly to the proper taxing authority. This agreement will remain in effect and shall be part of each order which we may hereafter give to the Purchaser and shall be valid until cancelled in writing by either party or revoked by the state.
- The taxable items described on any attached order or invoice will be resold by the Purchaser within the geographical limits of the United States of America, its territories and possessions, or within the geographical limits of Canada, in their present form or attached to other taxable items to be sold.
- The Purchaser understands that if they make any use of the items other than retention, demonstration or display while holding them for sale, they must pay sales tax on the items at the time of use based upon the purchase price.
- The Purchaser understands that it is a criminal offense to give a resale agreement to the Seller for taxable items that they know, at the time of purchase, are purchased for personal use rather than for the purpose of resale, and depending on the amount of tax evaded, the offense may range from a Class C misdemeanor to a felony of the second degree.
